Who is this course for?

Anyone working with **young people** (aged 11 to 25) who are using abuse/violence against parents/other family members or **parents/carers** whose children have used abuse/violence against them.

Please note: this course does not address young people's use of violence in intimate relationships. DVIP offers this training separately.

What does the course cover?

- How and why young people are using violence and abuse in their family relationships
- The impact of violence/abuse on parents/carers, particularly in families with a history of domestic violence
- Guidance on supporting parents and de-escalation strategies
- Having conversations with young people about violence/abuse
 - Challenging abusive behaviour and supporting change
 - Supporting safe choices and realistic safety planning
- Working in partnership to safeguard
- Case studies*
